8. Discussion on Watauga Improving Neighborhoods Program revitalization efforts

Chairperson Reyna mentioned there is a tentative WIN meeting scheduled for September 7th. Currently there are six homes that are eligible and approved for the program. Mr. Rodney Gattis from 6Stones stated that it would be ideal if the City had ten properties for the October blitz. The fall blitz will be October 21-22, 2016. Mr. Gattis stated that Lockheed will be doing seven houses during the fall blitz and that 121 Church will have 150 men volunteering for after blitz work. Member DeVoss asked what process would be for having 7508 Clover Lane approved for the blitz since it was not approved during the course of the meeting. This property will be put on the next agenda for conditional approval. Randy Richards stated that if this home is conditionally approved, the property would be eligible for the next blitz since the City would have to wait for financial documents. There was some discussion from committee members regarding the process of conditionally approving and approving homes. There was discussion regarding the property at 5749 Bonnie Drive and the possibility of bringing that property back to the committee for review.

Randy Richards stated that there are on-going efforts to grow the program and volunteers. He also mentioned that it will be requested that each City department have two staff members volunteer for the program. The fall blitz kick-off will be at Hills Church on October 21, 2016.
