1. Zoning Board of Adjustment Case No. 16-01: Request for a Special Exception to Watauga City Code of Ordinances, Chapter 115 Zoning, Article V, Developmental Controls, Section 115-116, Antenna Facilities, Section C, Subsection (7) Setbacks, (a), stating that no antennas be erected in front or side yard. The applicant is seeking a special exception to place a 45 foot amateur radio antenna within the side yard behind the front building line. The property is 6620 Richardson Drive, and is known as Lot 8 Block 13 in the Watauga Heights Addition. It is located south of Oaklawn Drive and east of McCoy Drive. The property owner and applicant is Mr. Lowell Martin.
